John Duncan Wilburn Adventure Scholarship Eligibility

The John Wilburn Scholarship provides an award to individuals who wish to participate in outdoor adventure/environmental learning. The 2021 Scholarship will be \$1,100.

The scholarship will be for participation in an IRS qualified non-profit organization program or a university-affiliated outdoor or environmental program.

To be eligible, the recipient must be a U.S. citizen or in this country with legal status and currently enrolled in a two- or four-year college or university program.

Procedure for 2021 Scholarships:

Deadlines: Applications will be accepted starting in January 2021 and should be postmarked no later than May 1, 2021. The grant recipient will be announced in May.
