



Total Assets \$7.9 million

MESSAGE FROM THE PRESIDENT

Dear Fund Sponsors and Friends of the Foundation,

We are pleased to provide this annual report for 2021 and share with you the progress of Shenandoah Community Foundation as we work towards fulfilling our mission of connecting people who care with causes that matter.

We ended 2021 with 85 funds and total assets of \$7.9 million, an increase of \$1.5 million, or 22.8%, from the prior year. We attribute our growth to 5 new funds added during the year, strong returns in our investment portfolio, and the generosity of supporters whose donations exceeded \$1.1 million for 2021.

During 2021, we distributed over \$393,000 in grants and scholarships in our community. These awards included \$65,000 through our community grants program, \$124,000 in scholarships, and \$204,000 in additional scholarships and grants through our donor advised and other funds.

Awards were made for post-secondary education and to 50 nonprofit organizations serving in the areas of social services, health care, the arts, and the environment. Over the course of our 22-year existence, we have distributed over \$3 million in grant awards in these areas.

As we move forward into 2022, we want to especially recognize and thank leff Dalke who completed 13 years of service to SCF at the end of 2021. Jeff was truly extraordinary in his commitment to and leadership of the Foundation, serving in different capacities as a board member, treasurer, and president. Our organization is better because of him.

It is also with great respect and reverence that we recognize and celebrate the life of Warren French, Jr., the founder and generous supporter of SCF. Warren passed away in 2021 at the age of 98, and left what we and many would describe as an unparalleled legacy in Shenandoah County for generations to come (see page 4).

We are very grateful to the fund sponsors and to all of the donors and volunteers who generously support the Foundation. We strive to be good stewards of the resources you have entrusted to us. On behalf of the Board, thank you for your support and partnership.

A TRIBUTE TO WARREN B. FRENCH, JR.

1923-2021

How would you describe a life well lived? For those of us at Shenandoah Community Foundation, it can be summed up in two words—Warren French.

Warren was a monumental force for good in Shenandoah County—a man of both ideas and action that impacted our community. He is best known for his professional career in telecommunications, beginning as a general manager of the Farmers Mutual Telephone System of Shenandoah County and ultimately advancing to Chairman of the Board of its successor organization, Shenandoah Telecommunications Company. Recognized by his peers as a leader in the industry, Warren was inducted into the Independent Telephone Pioneers Hall of Fame in 1993.

Active on the boards of many organizations, Warren was both known and respected for his genuine care and concern for the welfare of our county's citizens. In 1999, he shared the idea of a community foundation and inspired others to help establish this organization that has touched the lives of most Shenandoah County residents. He and his wife Pat established the first donoradvised fund from which donations are made annually to many local nonprofit groups.

Warren's death at age 98 brought tributes from around the world. He will impact generations to come as his legacy continues. We celebrate the life of Warren French and are most grateful to him for investing his efforts in making Shenandoah County a better place.



SEARCH GROUP HOME

Shenandoah Community Foundation is proud to support Shenandoah County SEARCH, a non-profit organization whose mission is to provide a warm and nurturing home for intellectually challenged adults through their Group Home in Mount lackson. Their goal is to help the residents lead lives as independently as possible.

SEARCH was established in 1978 by Preston and Vivian Poole, and the Group Home continues to operate in their memory. Today SEARCH thrives under the leadership of Judy Franz, Chair of the Board of Directors, and Robin Tull, the Group Home Administrator, along with dedicated board members, staff and volunteers.

Judy Franz works passionately for the residents and continues the vision initiated by the Poole's over 40 years ago. When she is not spending time visiting with the residents, Judy works to support the Group Home by organizing fundraisers, reaching out to local businesses and community members for support, as well as managing grants and donations designated to SEARCH. She also oversees the SEARCH Thrift Store that generates significant income for the Group Home. Needless to say, Judy is known for going above and beyond for the Group Home residents as well as aiding the staff where most needed.

Robin Tull describes the residents and the staff as one big family. There are currently six residents at the Group Home under the care of 24-hour staff. The residents particularly enjoy doing crafts together, going to the local library, and taking field trips. When they aren't out on adventures, the residents get to relax and enjoy life at the Group Home and are often joined by Angel, a Pomeranian mix who is described as the home's therapy dog and unofficial security system.

Shenandoah County is fortunate to have SEARCH as a resource. The vision of the Poole's is alive and well today thanks to the board, staff, and many supporters throughout the community.

Meet with a Shenandoah Community Foundation representative to design the fund so it can achieve your goals.

Create a name for your fund, and offer a tax-deductible gift to your fund now or later through your estate.

As your fund is invested for long-term growth, watch the meaningful difference your giving makes as you support your favorite causes.
